I. Business Meeting

3. Approval of Consent Agenda

a) Minutes

The Minutes of the August 12, 2019 meeting submitted for approval.

b) Vouchers

Vouchers submitted for approval: 1827, 151952 through 152030 totaling \$1,307,346.67; 1828 through 1831, 152031 through 152041 totaling \$345,424.69; 1832, 1833, 1834, 152042 through 152096 totaling \$1,738,004.69.
