Commission President Asmussen called the meeting to order at 3:00 p.m.

#### 4. Public Comment

Butch Pierce asked the Commission to take into consideration that not all ratepayers get annual raises. Not happy about the rate increase and wages of the PUD.

Rod Haeberle expressed his concerns that rates and wages keep going up.

Mike Cusick reminded the Commission that they are working for the ratepayers, not the PUD.

Commissioner Colyar moved to approve the consent agenda items a through d, seconded by Commissioner Vejraska; the consent agenda was approved unanimously.

#### 6. Unfinished Business

# a) Resolution No.1808 - 2024 Budget

Resolution No. 1808 was brought to the Board for the second reading along with four options ranging from a zero percent rate increase to the proposed 3.75%, which follows the Equity Management Plan.

After an hour-and-a-half-long discussion, Commissioner Colyar motioned to have a 1% increase for the 2024 budget year. Commissioner Vejraska seconded the motion and motioned to amend the motion to a .5% residential increase only. With no second to Commissioner Vejraska's motion, the original motion of 1% was voted on. The resolution passed two votes to one.

### 7. New Business

## a) Resolution No. 1809 - 3 Phase Scanner Surplus

Resolution No. 1809 was brought to the Board for a surplus of a 3-phase scanner that the District no longer uses.

Commissioner Vejraska moved to approve Resolution No. 1809, first and final, seconded by Commissioner Colyar. The resolution passed unanimously.

# 8. Administrative Reports

## a) Managers Report

General Manager Taylor reported he signed:

- NC 2023 Horrocks extended the contract date to March 31, 2024
- The ECESD contract will provide school districts with electrical safety and other vital information for the 2023-2024 school year. Contract not to exceed \$27,122.00.

General Manager Taylor reports he is still working with the Okanogan Irrigation District as per the last meeting.

Taylor reported he, along with Ron Gadeberg and Dale Dunckel, attended the Power Conference in Portland and a meeting with Douglas PUD as well.

# b) September Financial Report

Janet Crossland, Director of Finance and Accounting, provided the September 2023 budget overview and customer statistical and financial report comparing the Equity Management Plan to actuals for the 12 months ending September 2023.
