Changes April 1, 2022


Based on the increasing cost of power, the increasing cost of replacing aging infrastructure, and the ongoing cost to maintain our equipment, electric rates will increase as of April 1, 2022. **Current charges are listed below in black, with the new charges in blue.** Each customer class shows the average percentage that charges will increase, but the exact increase will vary by how much energy is actually used. Different adjustments were made per class to move toward a more equitable structure, in which each class pays based on its actual cost of service. COPA ALL CLASSES

Cost of Power Adjustment:
\$0.0006/kWh **\$0.0030570/kWh**

The Cost of Power Adjustment (COPA) is figured each year based on the actual cost of energy purchased. It will go up in 2022 due to high energy prices in 2021. **Among those high-price times were two high-use records for PUD customers, one in summer (June 29) and one in winter (Dec. 27).**
